Circular:

To the Trusts/ Societies/ Section 25/8 companies / Private Universities/ State Universities (hereafter referred to as Sponsoring Body) that runs Self-Financed Professional Technical Programs in the state of Gujarat.

The Fee Regulatory Committee (Technical) is in process of determination of fee structure for the professional programs covered under the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 and as amended from time to time, conducted on self-finance basis in Gujarat State for the students to be admitted in the academic year 2023-24, 2024-25 & 2025-26.

It is mandatory for the institutions under the jurisdiction of the Committee in Gujarat State, which conducts any of the following programs to get their fees determined by the Fee Regulatory Committee (Technical).

- 1. Bachelor of Engineering and Technology and the Diploma in Engineering (including integrated diploma-degree program).
- 2. Bachelor of Pharmacy and the Diploma in Pharmacy.
- 3. Bachelor of Architecture and the Diploma in Architecture.
- 4. Bachelor of Hotel and Tourism Management and the Diploma in Hotel and Tourism Management.
- 5. Master of Business Administration
- 6. Master of Computer Application
- 7. Master of Engineering or Technology
- 8. Master of Pharmacy
- 9. Bachelor of Planning
- 10. Master of Planning.
- 11. Bachelor of Architecture and Interior Design.
- 12. Master of Architecture

The Committee has also commenced the process of drafting the Standard Operating Procedure (SOP) for the years 2023-24, 2024-25 & 2025-26.
