Circular: -

This is to bring to the notice of Trusts/ Societies/ Companies formed under Section-8 of the Companies Act, 2013 or under section-25 of Companies Act, 1956 / Private Universities/ State Universities (hereafter referred to as Sponsoring Body) that runs Self-Financed Professional Technical Programs in the state of Gujarat that,

the Fee Regulatory Committee (Technical) ('the Committee' for short) is constituted under section-9 the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007, ('the Act' for short) for the purpose of fixation of fees in Technical Educational colleges and institutions in the State. For the admission of the students in the professional courses conducted on self finance basis for the block period of three years starting from 2020-21, 2021-22 & 2022-23 the Committee has commenced the process of determination of the fee structure for such courses. As per Section-10 of the Act, it is mandatory for every institution of college in the State which conducts any of the programs mentioned in section-2(k) of the Act viz.

1. Bachelor of Engineering and Technology and the Diploma in Engineering (including integrated diploma-degree program).
2. Bachelor of Pharmacy and the Diploma in Pharmacy.
3. Bachelor of Architecture and the Diploma in Architecture.
4. Bachelor of Hotel and Tourism Management and the Diploma in Hotel and Tourism Management.
5. Master of Business Administration
6. Master of Computer Application
7. Master of Engineering or Technology
8. Master of Pharmacy
9. Bachelor of Planning
10. Master of Planning.
11. Bachelor of Architecture and Interior Design.
12. Master of Architecture

to get their fee structure determined for such programs by the Fee Regulatory Committee.
