Sub: - FRC (Technical)-Imp-Urgent- Proposal for raising the Fee Structure above 5% of existing fees for the fee block commencing from the year 2020-21.

This has reference to the consent submitted earlier online and thereupon proposed fee structure above 5% of existing fee of the year 2019-20 for the fee block up to three years commencing from the year 2020-21. In this regard, institution has also submitted the sponsoring body's resolution for the proposed fee structure in the format prescribed by the Committee.

As a part of further process, such institutions are required to submit the online fee proposal for fee block commencing from the year 2020-21 by log into the FRC portal (<a href="http://103.20.104.102/FRC/Login">http://103.20.104.102/FRC/Login</a>) by using FRC Institution code as USER ID and the password, which the institution has used successfully in the past.

The portal will remain open from 05/07/2021 @ 4.00 p.m. to 20/07/2021 @ 5.00 pm.

After successful submission of fee proposal on the portal, the institution is required to submit the report in hardcopy along with the following documents.

a. Title Page (generated through the portal).

- b. Institute Report (generated through the portal).
- c. All documents uploaded on the portal.
- d. Sponsoring Body Resolution (Original), as submitted earlier on the portal.
- e. Declaration cum Undertaking (Original). (As prescribed by the Committee).

Also, each and every page of the documents in the hardcopy is required to be stamped and signed by authorised person of the institute.

The required processing fees as per following circular, need to be paid online while submission of the fee proposal.
