However, the fees mentioned in column 5 above shall be applicable to all students to be admitted in the institution for academic year 2016-17 and shall continue till completion of his course in the said institution. The institution is not allowed to charge or collect any fee other than the fee mentioned in column 5 and also not allowed to collect the fee at a time amounting to more than one term fee from a student in an academic year.

The reduced fees will be the baseline for the institutes for an academic year 2017-18.
