(In pursuance of power conferred upon Officer on special duty by the Fee Regulatory Committee (Technical) vide its resolution dated 21st January 2023 the following circular is issued.)

CIRCULAR:

For Newly started Colleges/Institutions and the New program started in existing Institutions which are added for the academic year 2022-23 after the declaration of fee structure on 30/12/2022 (Second List), the Committee determines the fee structure for the year **2022-23** only as per the **Appendix-I** attached herewith.

As the programs listed in **Appendix-I** are started from the academic year 2022-23, the financial data for the previous years is not available for them. Hence the fee structure for these programs is determined based on the Standard Operating Procedure of the Committee as well as the fees charged by either the other institutions under same trust offering similar programs or similar institutions in the nearby areas for the similar programs.

The fee structure determined by the committee is applicable to the student who is admitted in the academic year 2022-23 and it shall continue to apply till completion of his or her course in the said institution. However, the fee structure is subject to any direction, circular, order or notification that may be issued by the Government of Gujarat, Government of India, any Statutory or Regulatory Body or any Court of Law with regard to fees to be charged by such institutions/colleges for any other period that may be directed by it.

As per section 11 (2) of the Act, the fee structure indicated in **Appendix-I** to this Circular includes all types and kinds of fees such as Tuition fees, Library fees, Laboratory fees, Computer Fees, Caution Money, Gymkhana, Internet, Sports and Recreation and Self/Personality Centers fee, University Affiliation fees (if any) and the like. As such the institution shall not collect any other fee from the students except the fees as mentioned in **Appendix-I** to this circular. It is also not allowed to collect the fee at a time amounting to more than one term fee from the students in an academic year.

The institutions listed in **Appendix-I** to this circular shall have to submit their proposal for the next fee block commencing from the year 2023-24 to 2025-26 in the format as prescribed by the Committee, along with detailed audited financial data for the financial year 2022-23.
