(In pursuance of powers conferred upon Officer on special duty by the Fee Regulatory Committee (Technical) the following circular is issued.)

CIRCULAR:

The Committee has received applications for determination of the fee structure for the programs listed in **Appendix-I** which are under the purview of the Committee. These programs are either newly started from the academic year 2023-24 or reinstated in the year 2023-24. As these programs are added under the purview of the Committee from the academic year 2023-24, the financial data for the immediate preceding years is not available for them. Hence the fee structure for these programs is determined based on the Standard Operating Procedure of the Committee as well as the fees charged by either the other institutions under same trust offering similar programs or the institutions in the nearby areas which are offering similar programs. Considering the factors mentioned herein, the Committee now prescribes the fee structure for the year **2023-24** only for the institutions listed in **Appendix-I** attached herewith as per the following terms and conditions.

The fee structure determined by the committee is applicable to the student who is admitted in the academic year **2023-24** and it shall continue to apply till completion of his or her course in the said institution. However, the fee structure is subject to any direction, circular, order or notification that may be issued by the Government of Gujarat, Government of India, any Statutory or Regulatory Body or any Court of Law with regard to fees to be charged by such institutions for the year 2023-24 or any other period that may be directed by it.

As per section 11 (2) of the Act, the fee structure indicated in **Appendix-I** to this Circular includes all types and kinds of fees such as Tuition fees, Library fees, Laboratory fees, Computer Fees, Caution Money, Gymkhana, Internet, Sports and Recreation and Self/Personality Centers fee, University Affiliation fees (if any) and the like. As such the institution shall not collect any other fee from the students except the fees as mentioned in **Appendix-I** to this circular. It is also not permitted to collect the fee at a time amounting to more than one term fee from the students in an academic year.

The institutions listed in **Appendix-I** to this circular shall have to submit their proposal for the next year i.e. 2024-25 in the format as prescribed by the Committee, along with detailed audited financial data for the financial year 2023-24.
